Mayo Hospital, Lahore, under the guidelines of the Specialized Healthcare & Medical Education Department (SHC&ME), invites sealed bids from eligible bidders from licensed / operational pharmacies (located within 10 km Radius) and registered vendors of good repute for walk-in-registration for online Day To Day Local Purchase and limited/ petty purchase through quotation during Financial Year 2024-2025 along with the bid security 50,000/- in the name of CEO, Mayo Hospital, Lahore.

- Bids are required to be submitted by interested bidders in the Conference Room of Surgical Tower of this hospital on 16-08-2024 by 10:00 AM and shall be opened publicly on the same day at 10:30 AM in the presence of the applicants or their authorized representatives and the respective committees,
- The detail of scope of services TORs and other information will be available in the bidding document that can be obtained from Almoner office, Mayo Hospital, Lahore and can also be down loaded from PPRA website (www.ppra.punjab.gov.pk) and Mayo Hospital website (www.mayohospital.gov.pk). Payment of tender fee Rs.2000/- (Non-Refundable) at Almoner office is mandatory before the submission of tender.
- Walk-in-registration is a continuous process and will continue on daily basis throughout the financial year. Interested vendors / bidders can submit their applications to medical superintendent, Mayo Hospital Lahore, Convener Registration Committee during office hours.
- The bid should be submitted with proper sign and stamp on each page along with the properly marked page numbers and index attached.
- Operational pharmacies for online LP Day to Day should be within the 10km radius of Mayo Hospital Lahore; otherwise the application will be considered rejected.
- Tender can be purchased for Rs. 2000/- (Non-refundable) from Almoner Office of Mayo Hospital Lahore.
- In case the date of opening is declared as a public holiday by the Government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of applications accordingly. The time and venue shall remain the same.
- The policy instructions issued by SHC&MED from time to time shall also be applicable.

Note: The process shall be carried out as per Punjab Procurement Rules, 2014 (amended upto date) shall be applied.
